
<b>MATERIAL</b>	<b>HS</b>
<b>Wooden laths</b>	<b>4407</b>
<b>Pallet blocks, particle board, OSB...</b>	<b>4410</b>
Fibreboard, MDF, HDF, hardboard...	4411
Plywood	4412
<b>Wooden packaging (pallets, collars, boxes and crates)</b>	<b>4415</b>
<b>Cardboard products</b>	<b>48</b>
Wood waste (from new timber: waste or sawdust)	4401

**HS** codes are used to determine tariffs, taxes (INTRASTAT), and trade regulations for imported and exported goods. The HS code is a multi-digit code, typically starting with six digits that are internationally harmonized. For EUDR only the first digits (mentioned above) are important.


# WHAT IS OUR ROLE?

- **Operator:** we change the HS code (first part)
  - E.g. we buy wooden laths (4407) and pallet blocks (4410) in order to produce a wooden pallet (4415).
- **Trader:** we don't change the HS code (first part)
  - E.g. we buy wooden laths (4407) and resell wooden laths, unworked or not (4407)
  - E.g. we buy a wooden pallet (4415) and combine it with a cardboard box (4415)
  - E.g. we buy a pallet collars and combine it with a pallet (4415)
- **Out of scope:** we only use used/recycled material
  - E.g. we collect (unrepaired!) used wooden pallets and resell them
  - E.g. we collect used wooden pallets and repair them with wood from other used pallets
  - E.g. we collect wooden pallets and disassemble them to sell the used wooden laths



# 5. REUSABLE PACKAGING

## TARGETS FOR TRANSPORT PACKAGING

2030: 40% reusable within a re-use system  
100% (EU territory, between linked sites)


2040: 70%

**Exemption:** packaging for the transportation of large-scale machinery, equipment and commodities for which packaging is custom-designed to fit the individual requirements of the economic operator that made the order.

**Exemption:** cardboard boxes.




- Bij aanschaf bij een Nederlandse leverancier is de leverancier de producent.




